Introduction to FCC Online Education

The FCC education modules are available on The Grain & Feed Trade Association (“GAFTA”) online learning platform ‘Agribility – training for international trade’. All enquiries regarding FCC online education modules should be made to the FCC Secretariat (fcc@cocoa federation.com).

All FCC online modules take approximately 40 minutes to complete and are easily accessible from a laptop, computer, mobile phone, or tablet. You can also use the Agribility Platform App – instructions for iPhone and Android can be found on our website.

More FCC modules will be introduced to the platform over time so please keep an eye on our website for the list of available modules, which will constantly be updated.

Pricing

The price per module is as follows:

- **FCC Member: £75 per module**
- **Non-Member: £125 per module**

Once registration for the module is confirmed, the FCC will issue an invoice in respect of the module fee. Upon payment of the invoice access to the module will be granted.

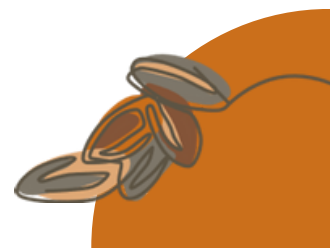
Module Format

Each module will begin by explaining the learning outcomes.

There are knowledge checks to ensure you understand the content as you progress through the module.

Each module ends with a short multiple-choice assessment which is graded. In order to pass you have to score a minimum of 70% correct answers, after which an FCC-accredited electronic certificate of completion is available. You will have three attempts to achieve a score of 70% in the multiple-choice assessment to obtain the certificate.

If you are unable to achieve 70% within three attempts, you will fail the module and not receive a certificate.

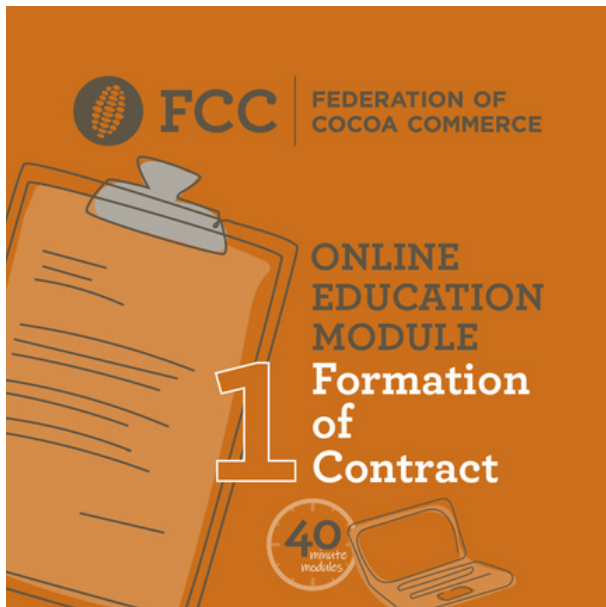

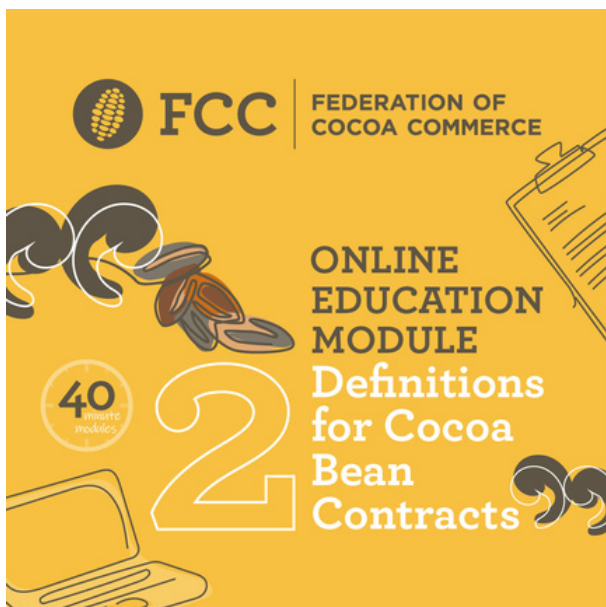

- How the responsibilities and duties of Buyer and Seller can change in the event of a potential default



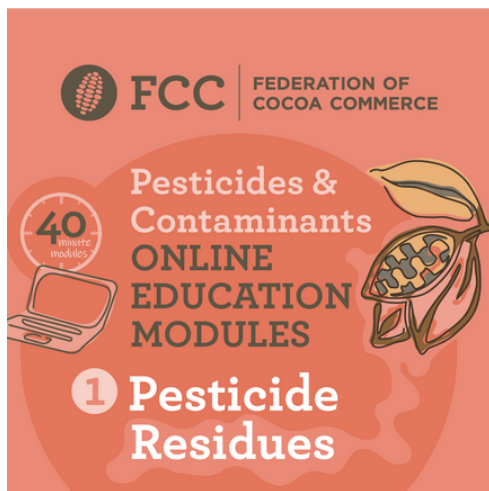

Our Pesticides & Contaminants Series is designed to help cocoa industry professionals understand critical aspects of pesticide residues, contaminants, and sampling techniques.



Pesticides and Pesticide Residues

This module will explore:

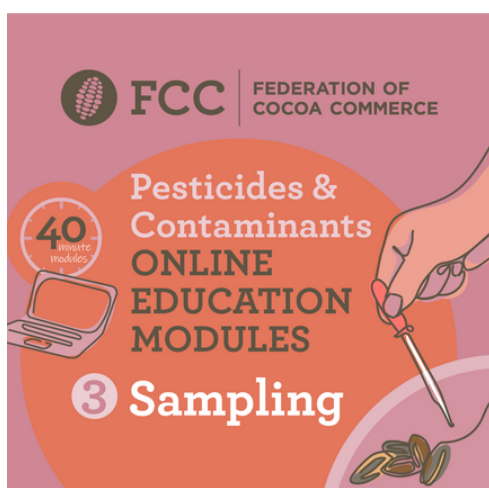
- Major pest and disease issues in cocoa growing regions
- Reducing pesticide use with Good Agricultural Practice and Integrated Pest Management
- Safe and effective pesticide use
- Regulation and monitoring of pesticide residues in major importing regions
- Methods to detect pesticide residues



Contaminants in Cocoa

This module will look at the primary contaminants of concern in cocoa beans and cocoa products:

- Cadmium
- Ochratoxin A (OTA)
- PAH
- MOSH/MOAH



Sampling

This module will explore:

- The importance of collecting a representative sample for an accurate assessment of the lot
- How composite sampling works
- The FCC sampling rules for bean quality assessment and how these relate to EU sampling regulations



How to Register

To register for an FCC online Module, you must complete the [online registration form](#) and select the name of the module you wish to complete from the list.

Upon receiving your registration form, the FCC will be in touch within three working days to issue an invoice in respect of the module fee.

Once payment is received, access to the module will be given for a period of eight weeks, in which time you must ensure to complete the module and the module assessment in order to receive the electronic certificate.

The eight-week period of access will begin from the date you are given your login details from the FCC.

Please note that there is a limit to the number of students who can access the platform at one time. If you register to complete a module but the capacity is full, you will be added to the waiting list and provided with your login details once a space becomes available. The wait time to join a module will never be longer than eight weeks.

Frequently Asked Questions

1. How do I access learning materials?

Once your registration is confirmed, you will be sent a confirmation with a link to the Agribility platform. You will be given a username and password which you must keep safe.

2. What do I have to do to pass?

There is a multiple-choice question assignment at the end of the module. You need to achieve 70% to pass. You will have three chances to pass.

3. How long is each Module?

It will take approximately 40 minutes to complete.

4. Can I enrol on more than one module at a time?

Yes, you can enrol on any available modules at one time.

5. What language is the course in?

Modules 1 and 2 are available in English and French. Modules are launched in English first and the French versions follow shortly after. Modules 3, 4, and the 'Pesticides and Contaminants' Series are available in English only.



6. Can I complete the modules on my phone or tablet?

Yes, but currently the platform will not work without a wifi connection or mobile data enabled.

7. How long will I have access to the Module?

Once your registration is confirmed, you will be able to log into the module for 8 weeks from the date you receive your login details.

Terms and Conditions

1. Registration and Access

Access to the module will be given once full payment has been received by the FCC.

Your full name and email address will be shared with The Grain & Feed Trade Association ("GAFTA") for registration purposes only.

Once registered, you will receive your own unique login details. By registering, you agree not to share these details with any other person. Any student suspected of sharing their module access will have their access suspended and may be prevented from continuing with the module. No refunds will be issued in this case.

Access to the module is granted for eight weeks and the start date of all access is deemed to be the date that your login details are provided.

2. Cancellations and Refunds

Once payment is received in full you will be given access to the learning platform and online course materials for a period of eight weeks. **You are no longer eligible for a refund after you have accessed the learning platform.**
